## **217/19 MINUTES**

a) Council Meeting – 9 March 2020

**RESOLVED:** that the Minutes of the above Meeting be received and confirmed as a correct record and signed by the Mayor.

## **218/19 ANNUAL MEETING AND MAYORAL SUCCESSION**

Following the recent legislative changes introduced by the Local Authorities (Coronavirus) (Meetings) (Wales) Regulations 2020, the Council discussed the timing of the Annual Meeting and the scheduling of the Mayoral Succession. It was felt that a change in leadership during the current national crisis should be avoided, especially given the vast local government experience of the current Mayor.

**RESOLVED:** a) to defer the Annual Meeting until late 2020; b) to maintain continuity the Mayor and Deputy Mayor for the municipal year 2019/2020 remain in their current positions for the whole of the 2020/2021 municipal year; c) a motion of thanks to the Mayor and Town Clerk for the leadership and hard work they have demonstrated since the onset of the current crisis was unanimously approved.

## **219/19 COVID-19 SUPPORT GRANT**

It was reported that the COVID19 Support Grant, established in March 2020, has awarded £7,800 to local charities and community groups assisting those suffering greater hardship as a result of the COVID19 pandemic. Early accounts from recipient organisations confirm that two £1,000 grants had resulted in a total of over 450 food boxes being distributed to residents.

**RESOLVED:** To extend the scheme for a further three months and to make available a further £5,000 per month to the project.

## 220/19 PIER UPDATE

The Pier restoration programme is currently paused part-way through phase four. The scaffolding around the relevant area has been in situ for almost eighteen months and needs to be dismantled by October 2020 at the latest. It was discussed whether to dismantle the scaffolding or to proceed with phase four to completion.

**RESOLVED:** To defer a final decision on phase four of the Pier until a specific meeting on the topic can discuss the costs and implications in detail.

## 221/19 BANGOR ORCHARDS

The establishment of two orchards in Bangor was debated. The first, a proposal between a Bangor University student and City and County Councillors, to establish an orchard in Bangor on City Council land was received. This was followed by a discussion on the Japanese Cherry Trees, which are scheduled to arrive in the autumn.

**RESOLVED:** a) to confirm that the Japanese Cherry Trees are still arriving, as planned, given the current international crisis; b) to begin preparatory work on the land in Ashley Jones Field for the Japanese Cherry Tree; c) to request that the proposer of the Bangor Orchard present a report to the Council; d) to establish a Strategic Planning Committee to examine the City Council's land and assets with a view to the preparation of a coordinated blueprint.

Henllys Ffordd Deiniol, Bangor. **Objection - there are already an excess of HMOs in this area of the City and this application will increase this capacity in an already overdeveloped area. The application states that 24.9% of existing properties in the Ward are HMO's. The City Council challenges this figure as being too conservative and believes the true percentage is noticeably higher. Can the percentage be verified, please?**
