#### **138/17 APOLOGIES**

#### **141/17 CHRISTMAS LIGHTS SWITCH-ON**

It was noted that there would be a switch-on of the Christmas lights around the Town Clock at approximately 3.45pm on Saturday 2 December, 2017.

#### **142/17 PROPOSED CHANGES IN THE REMUNERATION OF MEMBERS OF COMMUNITY AND TOWN COUNCILS**

Members received the report of the Sub-Committee which had discussed the report of the Independent Remuneration Panel for Wales (IRPW). The IRPW had powers over the allowances payable to elected members of Community and Town Councils. Previously the Panel's determinations for Community and Town Councils were permissive and each Council would decide whether to apply the determinations. However under new powers issued by Welsh Government, if the Panel adopt the Determinations following the consultation, they will become mandatory giving the Council no choice but to implement the scheme of payments and provision would have to be made within the budget for a scheme of Members allowances.

It was also noted that Community and Town Councils must also publish a Statement of Payments by 30th September each year. This document details all payments made to elected Members in the previous municipal year.

**RESOLVED:** that in the event of the IRPW's determinations:

- (a) becoming law: then the appropriate scheme of Members' Allowances be put in place wef April 2018 and budgetary provision be made in any case for that scenario; and
- (b) remaining discretionery: then the Sub-Committee's recommendations be implemented ; thus:-
  - 1) £150 a year to cover telephone, IT and other costs **Recommendation** – do not adopt
  - 2) £500 for up to 3 members with special responsibilities (e.g. a committee chair) **Recommendation** – do not adopt
  - 3) A civic allowance for the Mayor or Chair of the Council **Recommendation** – already in place review as appropriate
  - 4) A civic allowance for the Deputy Mayor or Deputy Chair of the Council **Recommendation** – already in place review as appropriate
  - 5) Reimbursement of travel and subsistence costs when on official business **Recommendation** – already in place review as appropriate
  - 6) A financial loss allowance **Recommendation** – do not adopt
  - 7) Reimbursement of the costs of care for a dependent child or adult of up to £403 a month **Recommendation** – adopt subject to the claim being in writing supported by receipts

#### **143/17 APPOINTMENT OF INTERNAL AUDITOR**

The Town Clerk reported that following the retirement of the City Council's previous long serving Internal Auditor quotations had been sought from appropriately qualified or experienced bodies and these were considered carefully by the Committee.

**RESOLVED** that the Gwynedd Audit Service be appointed as Internal Auditors for the financial year 2017/18.

**144/17 WEBSITE/E-MAIL**

The Town Clerk reported that the new web addresses were now in place and working – bangorcitycouncil.gov.wales and cyngordinasbangor.llyw.cymru. Associated with this, the new Councillor emails were also working and were displayed bilingually on the website.

**145/17 PUBLIC CONVENIENCES**

In accordance with previous discussions, the Town Clerk had contacted Gwynedd Council with regard to the future of the public conveniences within the City, as there had been some concern expressed about the City Council's continuing contribution of £10,000 per annum but little or no input. Gwynedd had now agreed to open negotiations on how the City would be best served in future with regard to this service.

Members also commented on how further services could be brought into the debate, however it was imperative that the future of public conveniences be debated as soon as possible given the budget issue.

**RESOLVED :** that the Town Clerk open negotiations on options for the future fuding and service provision of public conveniences within the City.

**146/17 PIER UPDATE – CAPITAL PROJECT**

The Town Clerk reported progress on the Pier restoration project and that mechanical cleaning work had commenced on the steelwork. He also reported that a joint meeting of the Pier Client Group and Council's Financial Approvers had taken place to discuss in detail the preparation, work so far, lessons learned, public perception, sandblasting and welding contracts amongst others.

It was noted that many contracts were now coming into place following approval, for scaffold,sandblasting/mechanical cleaning, welding and paint supply and spraying. Financial details were approved by the Group including consultancy fees, surveys and overall payment of invoices, so far, of £97,358.64 and committed expenditure, so far, of a further £282,340.72.

**RESOLVED :** that the report be received, progress and finances noted and actions approved.

**147/17 REQUEST FOR FINANCIAL ASSISTANCE & FINANCIAL DONATIONS**

The Clerk reported that two completed applications for financial assistance had been received.

O'r blaen roedd penderfyniadau'r Panel dros Gynghorau Cymuned a Thref yn rhai caniataol a byddai pob Cyngor yn penderfynu p'un ai i ddilyn y penderfyniadau ai peidio. Fodd bynnag, o dan bwerau newydd a roddwyd gan Lywodraeth Cymru, os yw'r Panel yn mabwysiadu'r Penderfyniadau yn dilyn yr ymgynghoriad, byddant yn dod yn rhai gorfodol. Yna ni fydd dewis gan y Cyngor ond gweithredu'r Cynllun taliadau a byddai'n rhaid darparu o fewn y gyllideb ar gyfer cynllun o lwfansau Aelodau.

Nodwyd hefyd fod yn rhaid i Gynghorau Cymuned a Thref gyhoeddi Datganiad o Daliadau erbyn 30 Medi bob blwyddyn. Byddai'r ddogfen hon yn manylu ar bob taliad a wnaed i aelodau etholedig yn y flwyddyn ddinesig flaenorol.

  - 6) Lwfans colled ariannol **Argymhelliaid** – peidio â mabwysiadu
  - 7) Ad-dalu costau gofal ar gyfer plentyn neu oedolyn dibynnol hyd at £403 y mis. **Argymhelliaid** - mabwysiadu cyn belled â bod yr hawliad mewn ysgrifen ac yn cael ei ategu gan dderbynebau.

Nodwyd fod llawer o gcontractau yn dod i'w lle bellach yn dilyn cymeradwyaeth, ar gyfer sgaffaldiau, swndio/glanhau mecaniddol, weldio a chyflenwi a chwistrellu paent. Cymeradwywyd y manylion ariannol gan y Grŵp ac roedd y rhain yn cynnwys ffioedd ymgynghorwyr, arolygon a thalu anfonebau, gwerth £97,358.64 hyd yma, a'r gwariant ymrwymedig, hyd yma o £282,340.72 pellach.
