232/18 APOLOGIES

235/18 INDEPENDENT REMUNERATION PANEL FOR WALES

The Town Clerk informed Members that the Final Report of the Panel 2018/19 had been published with no significant changes for Town and community Council.

RESOLVED: that the report be received and the scheme in place for Member expenses remain unchanged.

236/18 UNDERGROUND NUCLEAR WASTE DUMP IN WALES

The Town Clerk read out a letter from Jill Evans MEP, Chair of CND Cymru about communities having to volunteer to host an underground nuclear waste dump (Geological Disposal Facility). Any volunteering community would have a financial incentive to do so.

RESOLVED: that the City Council will not volunteer to host such a facility.

237/18 MEMBERSHIP OF ONE VOICE WALES 2019/20

Members considered the renewal of subscription for 2019/20 to this body and expressed some concern at the cost and whether it represented value for money in respect of the service received and Member benefits. It was unclear from the request how the calculation of £2014 figure had been arrived at.

RESOLVED that the Town Clerk request clarification from OVW on the estimated chargeable dwellings at 6294 as opposed to the Council Tax Base of 3885.63 and report back with findings.

238/18 FINANCE

a) Invoices for Payment - It was noted that invoices as detailed on the schedule totalling £12,402.82 had been approved.

239/18 EXCLUSION OF PRESS AND PUBLIC

RESOLVED: That under the provisions of the Public Bodies (Admission to Meetings) Act 1960, members of the press and public be excluded from the meeting due to the confidential nature of their business to be transacted.

240/18 GARTH PIER

The Town Clerk updated the Committee in respect of the following:

Landing Stage (Dolphin) - This amendment would require Listed Building Consent and CADW approval prior to which a detailed survey was required to justify the work.

Grants - Expressions of Interest had been completed and submitted to the Heritage Lottery Fund and CADW. A crowdfunding scheme on a pier recently had not created a great interest or donation. This would be done shortly to establish some fund-raising.

Best Practice Piers - Bangor (Garth) Pier had been selected for a short-list of best practice piers in the UK in terms of operation and management. This was a Coastal Revival Study by Bournemouth University.

Pavilion - There were some legal issues to be resolved, but once the clearance, was achieved also in terms of safety, a future strategy could be implemented.

Welsh Government - a letter had been submitted by the Mayor to the Welsh Government Minister for Culture to request any help possible regarding the Pier.

Delays - Some delays had been encountered in terms of timescales, works and other distractions.

Kiosks - Currently six kiosks were rented out. One undergoing significant repair works.

Other Property Matters - The Town Clerk reported various matters appertaining to the City Council's land ownership at Dargie Fields and Penrhyn Arms Woods and that some consideration was required as to the policy of the City Council in respect of land holdings for the future.

RESOLVED: that the sub-group already set up to deal with Community Assets be appointed to deal with all property matters. The Membership was Councillors D Hainge, John Wynn Jones, Keith Jones, Nigel Pickavance, Luke Tugwell and John Wyn Williams.

241/18 WALES AUDIT OFFICE REPORT

The Town Clerk reported details of the Reports on Town and Community Councils in Wales re: Internal Audit and Financial Management and Governance. The City Council had no citing's within these reports.
