194/18 APOLOGIES

Apologies for absence were received from Councillors Medwyn Hughes, Salik Rahman and Luke Tugwell.

195/18 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

Councillor Derek Hainge declared an interest in Item 199/18 Planning Applications – C19/0078/11/LL.

196/18 URGENT BUSINESS

The Town Clerk reported on the following matters of interest:-

- i) Forthcoming Events confirmed
28 April – Bangor Spring Food Festival and 10 May – The Moveable Feast (at the Pier)
- ii) A request from Gwynedd Council and Local Members to partake in a partnership to maintain the Penrhyn Park Playarea – this was referred to the Community Assets Sub-group for consideration; and
- iii) The City Council's submission to the Japanese Embassy for the acquisition of Japanese Sakura Cherry Trees had been successful. The proposed areas was Ashley Jones Fields, planting to commence in November 2019.
- iv) His Worship the Mayor reported that there would be various events celebrating St. David's Day including a City Centre March & Parade on Saturday 2 March.

197/18 NORTH WALES POLICE

Members received a presentation by Inspector Jon Aspinall who gave an overview of policing issues in the City which included:-

- Crimes committed and prosecutions
- Drugs and anti-social behaviour
- Crime figures
- Closure Orders
- Pub/Shop Watch Schemes
- Public Spaces Order
- Alcohol and begging
- Reductions in Staff and PCSO's

There then followed a question and answer session which concluded the presentation.

Members showed their appreciation for Inspector Aspinall's visit.

198/18 CCTV CAMERAS

The Committee welcomed Mr Steve Edwards, Operations Manager from Gwynedd Council who gave a presentation on the proposed replacement of Gwynedd's CCTV camera system. This would evolve from a Pan, Tilt & Zoom (PTZ) analogue system to a fixed modern WiFi HD Camera unmanned system.

He explained the reasons behind the proposals and Gwynedd Council's decision which would mean a saving in staffing.

However for the City Council this would mean an increase in contribution from the current £12K to a proposed £41K p.a.

Members expressed concern about the increased annual commitment and that there had not been any consultation as to where the new cameras would be placed in order to be more helpful in tackling crime. Also as it was not a live system that it would only be used retrospectively for evidence.

Councillor Elin Walker Jones and Owen Hurcum left the meeting at this point.

RESOLVED: that a small group be established to look at the detail and in the meantime, Mr Edwards to provide more information on camera location, financial detail once the tenders were received and proposed timescales in order that a plan could be formulated should the City Council take up this offer of CCTV provision.

199/18 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C19/0041/11/LL Conversion of floors above shop for 6 self-contained residential units together with associated alterations. 246 – 250 High Street. **No objections, however, some concern was expressed about arrangements for storage of waste and recycling both for the shops and the proposed six residential units.**

C19/0057/11/LL Extension and alterations to existing dwelling. 65 Penrhos Road. **No objections.**

C19/0074/11/CR Application for internal alterations (including erection of new partition wall with glazed door and replacement of pendant lights). Antelope Inn, Ffordd Caergybi, Treborth. **No objections.**

C19/0075/11/R4 Erection of security fencing and gates. Porthdy Pont Menai, Treborth. **No objection in principle, however, a better design was suggested for it to be more in keeping with the existing building and architecture around the iconic bridge.**

C19/0077/11/CR Erection of security fencing and gates. Porthdy Pont Menai, Treborth. **No objection in principle, however, a better design was suggested for it to be more in keeping with the existing building and architecture around the iconic bridge.**

C19/0078/11/LL Provision of 38 residential units (including a mixture of open market units and affordable units), parking accommodation and access. Former Bangor City Social Club, Deiniol Road. **No objections in principle, however, grave concern was expressed about the design (height, appearance and in keeping with the area), the access to the site could cause traffic movement problems and was not particularly safe for highway users and pedestrians. Also parking for residents and visitors was not adequate and should be looked at.**
