149/17 APOLOGIES

150/17 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

151/17 URGENT BUSINESS

- (i) **WELCOME** : The Chairman welcomed His Worship the Mayor, Councillor Derek Hainge back following his recent operation.
- (ii) **GWYNEDD COUNCIL SERVICES** : The Town Clerk informed Members that he had discussed the future funding of public conveniences and other services in the City. Gwynedd Council had requested a formal approach from the City Council outlining any proposals and ideas for future service provision including costings. **RESOLVED**: that the Town Clerk circulate a list to Members of possible services for review to Members and a Special Meeting be held when Councillors had reviewed the list and submitted ideas.
- (iii) **BANGOR MARKET** : The Town Clerk reported that he had met with The Bangor Market Franchise holders to review existing arrangements and consider a new Memorandum of Understanding between the City Council and Bangor Market Company. He reported a positive outcome and was hopeful that a new Agreement could be achieved. **RESOLVED**: that his news be received positively and the Town Clerk be thanked for his efforts in pursuing a new Agreement.
- (iv) **FREEDOM OF THE CITY** : His Worship the Mayor raised the matter of Freedom of the City and asked if Members wished to consider any names for this honour. **RESOLVED**: that the matter be considered by the Mayor, Deputy Mayor and Town Clerk and be placed on an Agenda in the near future for discussion.

152/17 PLANNING APPLICATIONS

RESOLVED : that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below:-

C16/1356/11/LL Change of use of land to enable the siting of a mobile catering unit and construction of a new vehicular access. The Pine Mine, Holyhead Road. **Objection on the grounds of road safety concerns for vehicles and pedestrians. This represents a danger to road users, would cause parking problems and there are concerns about food standards at mobile catering facilities.**

C17/1129/11/LL Single storey front extension and rear dormer window. 9 Lon y Deri. **No objection.**

C17/1165/11/HY Install 6 non-illuminated adverts in the supermarket car park. Unit 11/12, Menai Centre, Garth Road. **No objection.**

C17/1201/11/R3 Construction of a car park and 2 new vehicular access to the front of the property. Ty Cegin, Rhodfa Penrhyn, Maesgeirchen, Bangor. **Objection, this represents a loss of valuable green space on the Maesgeirchen estate and is not considered a necessity.**

C17/1176/11/CR Demolish and re-build single storey extension to rear of dwelling house together with internal and external alterations. 2 Bron Menai, Siliwen Road. **Objection, the proposed removal of a mature tree is considered unnecessary and unhelpful to the environment. The proposed development is not in keeping with the area.**

C17/1177/11/LL Demolish and re-build single storey extension to rear of dwelling house together with alterations to existing garage, and erection of summerhouse within the garden. 2 Bron Menai, Siliwen Road. **Objection, the proposed removal of a mature tree is considered unnecessary and unhelpful to the environment. The proposed development is not in keeping with the area.**

153/17 BANGOR IMAGE MEETING

The Town Clerk reported that a second “Bangor Image” meeting had been held with key stakeholders. The focus of the meeting was the alleviation of litter and improvements to Waste/Recycling collections to tidy up problem areas. A joint working programme had been suggested with some funding required. There was also a meeting promised between the Planning Department and Estate Agents to forge agreement to reduce the number of ‘To Let’ boards on permanent display in certain areas of the City. Members noted the situation and were very hopeful that these Meetings would improve the environment and the positive work could continue into 2018.

The Town Clerk reported on progress made with regard to the refurbishment project including details of scaffolding, mechanical, cleaning, sandblasting and painting. The budget for the scheme was also discussed.
