11/19 APPOINTMENT OF VICE-CHAIRMAN

RESOLVED: that Councillor Luke Tugwell be appointed Vice-Chairman of the Committee for the forthcoming Municipal Year.

12/19 URGENT BUSINESS

Councillors commented on the success of the Moveable Feast event which had been held on the Pier on Friday 10 May. It was agreed that a charge should be made if the event went ahead in future although in 2018 the event was not successful as it was very much weather dependent.

Councillor D Hainge referred to the former Mayor Evelyn Butler's recent illness and Members asked the Town Clerk to confer their best wishes to Mrs Butler.

13/19 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C19/0330/11/LL Rear extension and dormer window. 28 Ffordd y Coleg. **Objection as this property has already been altered to form 8 bedrooms. A further addition to form a 9th bedroom is an over-development of this existing HMO and would exacerbate the existing problems in this area.**

Councillor E Parry left the chamber for the discussion of the above application.

C19/0362/11/LL Demolish garage and erect a single storey annexe at the rear of the dwelling. Bryn Awel, Ffordd Deiniol. **Objection** to the proposal as it was deemed an over-development of the site.

C19/0372/11/LL Create a parking area and associated works. 45 Toronnen. **No objection.**

C19/0378/11/LL Two storey extension at rear. 14 Lon Bedw, Coed Mawr. **No objection.**

C19/0398/11/LL Application to demolish building (Use class B8) and erect supermarket (Use class A1), creation of 113 parking spaces, soft landscaping works, reconfiguration of site access, including the creation of a roundabout and alterations to existing parking arrangements fronting Dunelm Store together with alterations to service access. Blakemore Cash and Carry, Ffordd Caernarfon. **Objection as this development if approved is contrary to section 6.3 of the LDP i.e. "restricting the expansion of out-of-town retailing and leisure development". There is concern at the current level of traffic movements and congestion in this area. A further large retail outlet would generate an unacceptable increase in traffic flow on Caernarfon Road which is often gridlocked currently. The change of use from storage to retail is contrary to the planning policy for out-of-town developments.**
