## **57/19 URGENT BUSINESS**

### i) **Cancellation of Celebration Street**

Councillor Enid Parry brought to the attention of the Committee details of what had been planned as a celebration of graduation at the University within the City Centre. She expressed her disappointment at how event transpired.

Councillors agreed that it was a disappointing outcome but that the lessons learnt were valuable and that an event such as this was a good idea and the City Council could contribute to something similar next year within a partnership scheme.
