151/18 APOLOGIES

Apologies for absence were received from Councillors Medwyn Hughes, Owen Hurcum, Enid Parry, Salik Rahman, Mair Rowlands, Luke Tugwell, and Huw Wyn Jones.

152/18 DECLARATION OF FINANCIAL INTEREST OR PERSONAL CONNECTION

None.

153/18 URGENT BUSINESS

The Mayor informed the Committee of the death of a former Councillor and Mayor Geraint Huws Roberts. Councillors stood in silence as a tribute to Mr Williams.

- (i) National Eisteddfod Venue: The Mayor detailed a letter received from Caernarfon Town Council requesting the City Council's support in the bid to host the 2021 National Eisteddfod in Caernarfon. **RESOLVED:** that the City Council write a letter of support.
- (ii) The Mayor congratulated all the people involved in arranging the Christmas Food Festival on Sunday 16 December. It was noted that there was a lack of Welsh language in the adverts.
- (iii) The Town Clerk informed Members that the tenants of the 1st and 2nd floor of the City Council Offices had vacated the premises although the rental agreement still had several months to run.
- (iv) The Town Clerk gave details of the City Council's business closure over the Christmas period.
- (v) Abbey Road Centre: A request had been received for the organisation to attend a Council Meeting to give a presentation. However, the request had come from the Centre's Manager who had now left. The Town Clerk would contact the organisation to ascertain whether it still wished to attend a meeting.
- (vi) The Town Clerk reported that Gwynedd Council had requested an extension to the Public Toilet Partnership Scheme for the next two years with contributions being paid annually. **RESOLVED:** that this arrangement be agreed and that budget provision be made over the next two years.
- (vii) Concern was expressed at the lack of a One Stop Shop in Bangor and the Town Clerk was asked to record the number and nature of enquiries received in the office which were directly attributable to Gwynedd Council.

154/18 PRESENTATION BY SHARI LLYWELYN – Creative Producer, Pontio

Shari had stepped in as a substitute for Elen ap Roberts, Artistic Director to make a presentation to the City Council.

Shari concentrated on how Pontio interacts with Bangor community, students and communities outside of Bangor. Pontio aimed to engage with all people and organisations particularly with education, art, culture, projects and anti-social groups. Its work also included children and schools and a very popular event every two years – the Circus Festival.

The Chairman and Members thanked Shari for the interesting and useful presentation.

The Town Clerk reported details of the current consultation. Members were asked to submit any comments to the Town Clerk before the closing date for a response to be sent on behalf of the City Council.

158/18 CCTV

The Town Clerk reported the Gwynedd Council had submitted proposals to change the CCTV system from the current analogue series to PTZ (Pan, Tilt, Zoom) cameras. The System is 20 years old and due an update introducing new digital high definition technology.

The drawback would be the annual cost of the system for the City Council currently £12K : proposed £42K. The Town Clerk has asked for details of the cost effectiveness i.e. statistics for each cameras assisting with crime prevention and detection, however there were no details available.

Members expressed concern as to the increased costs and whether there were other ways of assisting the Police and protecting the public.

RESOLVED: that i) the budget be allowed to increase slightly but not to fund the proposals; and ii) the Operations Manager of the Municipal Works Unit at Gwynedd Council be invited to a meeting in the New Year to discuss the details.
