77/19 APOLOGIES

79/19 URGENT BUSINESS

The Chairman informed the Committee that he was updating His Worship the Mayor and the Town Clerk with regard to the situation with Nantporth CIC.

80/19 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C19/0573/11/LL Retrospective application for the change of use of from industrial unit (Use class B1/B2/B8) to a gymnasium (Use class D2) Uned 9, Rhes Seiriol. **No objection**

C19/0760/11/LL Change of use from use Class A2 (letting agent) to use class A3 (hot food takeaway) with internal and external alterations. 4 Ffordd y Coleg. **Objection – there are too many similar outlets of this type in the area, the development would cause traffic congestion and parking issues would be affected in this already congested area. Due to the flats above and a potential take-away there may be refuse collection problems leading to a build up and potential health hazards or pests.**

C19/0764/11/LL Extensions (amended scheme to that approved under application reference C19/0328/11/LL). 33 Bryn Eithinog. **Objection as the extension to the front would go beyond the building line, it is considered an over-development of the site and on traffic grounds it is on a dangerous bend.**

C19/0773/11/LL Variation of condition 2 of planning permission C17/0244/11/LL in order to change integral garage into an additional room. Tir gyferbyn / Land opposite - Tremlyn, Llwybr Dewi Sant. **No objection providing sewerage facilities are adequate.**

81/19 ONE VOICE WALES

The Town Clerk reported that in accordance with instructions he had written to One Voice Wales (OVW) to request a reduction in the Membership Fee. No response had been received and a letter had been sent to the Minister for Housing and Local Government also. The fee structure of OVW had remained the same for many years and was unlikely to change.

In the light of this news and the unfair way in which the fee reflected the actual Council Tax receive it was **RESOLVED** that the subscription to OVW be not renewed for 2019/20.

82/19 CCTV

Correspondence had been received from Gwynedd Council's Municipal Works Unit confirming there was no change in the fee payable for CCTV for the current financial year. Until a better understanding of the likely costs of the new cameras was reached no proposals for increased fees would be considered.

There was also an invitation to attend the CCTV control room on either the 18th or 25th September.

RESOLVED: that the report be noted and the offer of a visit to the CCTV Control Centre be accepted on either date and a further debate be held on locations and usage of CCTV Cameras in the City.
