42/19 CLIMATE CHANGE PRESENTATION

The City Council received a presentation on and the background to the recent Climate Change issues raised both nationally and locally. Meg Baker and Mark Barrow from Bangor University spoke on this subject matter. They explained the international position and what local Councils could do to help reduce pollution and the carbon footprint of its actions.

Members responded by expressing their own concerns on the impact that society was having on the climate and pollution in the air and in the oceans. The Deputy Mayor agreed to some work on the preparation of a Notice of Motion for consideration at a future meeting of the full Council.
