210/17 PLANNING APPLICATIONS

RESOLVED: that the Gwynedd Planning Authority be advised that the City Council have the following observations to make on the applications listed below: -

C18/0224/11/LL Change of use of existing building to use class A3 (pub/restaurant) together with alterations to the external elevations, demolition of two outbuildings and creation of a car park. Storfa Yng Nghefn/Store at rear - 37 Farrar Road. **No objection.**

C18/0030/11/LL Revised application to erect two storey building with 2 self-contained flats. Garages / Vacant Land, Church Street, Bangor. Revised plans received on 14/03/18. **Objection – The proposal is considered an over-development of a very restricted site.**

C18/0171/11/LL Single storey side extension. Laddas, 81, Ffordd Garth Uchaf, Bangor. Revised Plans. **No objection.**

C18/0238/11/LL Redevelopment of the site to provide 55 residential units, together with the creation of a new vehicular access, estate roads and associated paths, parking spaces and landscaping. Former Dickies Boatyard (Phase II), Beach Road. **Objection – The proposals are considered too large, too high and unacceptable for the area. It therefore would represent an over-development of the site.**

C18/0239/11/LL Change of use of former shop (A1) into a hot food takeaway premises (A3) to include the installation of an extractor system on the rear of the property. 293 High Street. **Objection – would cause significant harm to the amenities of the area and neighbouring properties would suffer air and noise pollution by way of the effect of noise and smell. Refuse arrangements are not considered adequate.**
